Purpose/Talking Points

- Facilitate Nominations Process of BOV members and its officers.
 - Encourage nominators to focus on nominating members that represent the diversity of the university <u>AND</u> meet BOV requirements
 - Factors (not limited to):
 - Geographic Location**
 - Gender/Sex
 - Race
 - Representation of alumni from each of the University's academic units

- Electronic Only Submissions through Nomination Cover Form.

Nomination Process

New Member Selection

Nomination Process (cont.)

Officer Nominations

- The association's Nominating Committee shall solicit nominations for the Officer positions from the membership of the Board of Visitors for the positions of Chair, Vice Chair and Secretary of the Board of Visitors.
 - Nominators should consider members who have demonstrated proven leadership, active participation, knowledge of the mission and aspirations of ECU and diversity of age, gender, ethnicity and geography.
 - Candidates for office must have completed a minimum of two (2) years of service on the Board of Visitors.
- Nominations will be vetted thoroughly by the Nominating Committee, including, but not limited to, interviews with prospective candidates and assessing involvement from the membership.
- One month prior to the Spring meeting, the slate of recommendations from the Nominating Committee will be sent to the membership of the Board of Visitors for review, and at the Spring meeting of the association, a formal vote will take place on the slate of officers to recommend to the Chancellor for concurrence and submission to the Board of Trustees.

Timeline

- January 19, 2024
 - NEW MEMBER nominations open;
 - OFFICER nominations open
- February 19, 2024
 - NEW MEMBER nominations close;
 - OFFICER nominations close
- Week of Feb. 22, 2024
 - Slate of OFFICERS is sent to BOV membership for review
- March 25, 2024 (HOLD)
 - BOV vote on new OFFICERS
- April 11-12, 2024
 - BOT vote on BOV NEW MEMBERS and OFFICERS



Timeline (cont.)

- One month for nominators to submit**
- Board of Governors set Board of Trustees Spring meeting earlier than anticipated
- Special meeting of BOV to be called sometime in March 2024 to vote on NEW MEMBER & OFFICER slates. UPDATE: A hold for Monday, March 25, 2024
- Committee met multiple times prior to nominations being open and will meet after close

- Summary of Minor Changes:
 - Deadline Date for Submissions changed to February 19, 2024.
 - Class to nominate for changed to Class of 2028
 - Removed option for manual submission to Megan Ayers
 - Moving forward on electronically-only submission
 - Removed Megan Ayers contact block
 - Edited field header names to streamline and provide clarity
 - Split Year/Degree/Major field into separate fields
